FPA Sri Lanka was awarded a prestigious grant aimed at enhancing women's well-being by integrating gender-based violence (GBV) screening into antenatal care.

This study will be implemented from July 1, 2024, to December 31, 2025, focusing on pregnant women in the estate sector.

The grant signing ceremony was held at the Netherlands Embassy in Sri Lanka,

graciously hosted by Mr. Iwan Rutjens, the Acting Ambassador of the Netherlands. Our proposal was one of seven selected from over 100 submissions by organizations dedicated to human rights.

Regional Workshop on Adolescent Sexual and Reproductive Health in Emergencies (ASRHiE)



FPA Sri Lanka hosted a 5-day workshop aimed at enhancing the capacity of IPPF Member Associations to implement SPRINT initiatives focused on adolescent sexual and reproductive health (ASRH) in emergency settings. This workshop covered essential SRH service provision for adolescents during crises.

We recognized the critical importance of ASRH in emergency contexts, which is why the SPRINT Project places a heightened emphasis on ASRHiE. Since joining the SPRINT Project in 2011, FPA Sri Lanka has significantly contributed to disaster management efforts across the country. This year marked the beginning of our focused efforts on ASRHiE.

In 2023, FPA Sri Lanka also hosted the regional Monitoring & Evaluation (M&E) workshop, and we were honoured to have been chosen to host this regional workshop as well.

Participants in this programme included Member Associations from India, Thailand, Maldives, Indonesia, Nepal, Pakistan, and the Philippines. Key attendees from IPPF Humanitarian included Dr. Raj, Senior M&E Advisor, and Ms. Edna Mokaya, Senior SRH Advisor. Additionally, representatives from the IPPF South Asia Regional Office, Arab Regional Office, and East & South East Asia and Oceania Regional Office were in attendance.

Participants left inspired and ready to implement their new knowledge, ensuring ASRH remained a priority in emergency settings.

As crucial first steps, FPA held consultation meetings with key government stakeholders, UN organizations, INGOs, NGOs, and Civil Society Organizations to gather insights on CSE content, platform development, and sustainability measures. Together we will work to revolutionize sexual education delivery.

FPA partnered with the Center for Evaluation at the University of Sri Jayewardenepura to host a workshop for students of the 'Advanced Certificate in M&E' course as part of gLOCAL Evaluation Week 2024.

gLOCAL Evaluation Week, commemorated in May, was a unique knowledge-sharing event convened and supported by the Global Evaluation Initiative (GEI). GEI helps countries strengthen their monitoring and evaluation systems to improve the lives of their citizens.

The session focused on the Monitoring and Evaluation Information Management System (MEIMS) of FPA Sri Lanka. It highlighted how the MEIMS serves as a vital tool for transparent and accountable reporting to donors, helps the organization track progress, identify gaps, make timely amendments to achieve desired results, and promotes learning and data-driven decision-making.

This session showcased the value that M&E brings to any organization. The main speakers were Mr. Suchira Suranga, Director of Organizational Learning & Evaluation, Mr. Amal Bandara, Assistant Director M&E and Mr. Janaranga Dewasurendra, Assistant Director M&E.

Inaugural Technical Committee Meeting for ReproSex 2024



The first meeting convened at FPA Head Office this morning brought together esteemed healthcare professionals and sexual and reproductive health experts to chart the course ahead. Chaired by Professor Emeritus of Demography Indralal de Silva, it included representatives from the FPA: Dr. Ruchitha Perera (Executive Director), Mr. Suchira Suranga (Director - Organization Learning and Evaluation), Mr. Suhail Junaid (Director - Marketing), and Dr. Nuzrath Nasoordeen (Director - Medical).

Participating organizations included the National STD/AIDS Control Programme (NSACP), Family Health Bureau, Centre

for Evaluation, Sri Lanka Medical Association, University of Jayawardanapura, Population Association of Sri Lanka, University of Colombo, Menopause Society of Sri Lanka, and the National Institute of Education.

The discussions covered conference proceedings, plenary session formats, and the abstract screening and review process.

ReproSex 2024, set for November 5th and 6th, aims to be a landmark event in sexual and reproductive health and rights (SRHR). The conference will advance reproductive rights, improve healthcare access, and address societal taboos and inequalities. Bringing together researchers, policymakers, healthcare professionals, activists, and community leaders, it will promote dialogue, innovative solutions, and impactful change.

Focused on holistic, rights-based approaches grounded in social justice and gender equity, ReproSex 2024 will explore SRHR complexities through thematic tracks, workshops, and discussions.

Master's Programme in Social Enterprises: Global Workshop 2024



The "Master's Programme in Social Enterprises" (MSe), organized by IPPF's Social Enterprise Hub, took place from May 27th to June 7th, 2024. The workshop was live-streamed via Zoom from FPA Sri Lanka, hosting 54 participants from 29 affiliated organizations across five IPPF regions. Since its inception as an on-site event in 2019, this two-week capacity-building programme has grown significantly, with 2024 being the sixth global workshop with the highest attendance to date. Each day featured approximately 4.5 hours of interactive sessions.

The MSe programme covered crucial business skills, including organizational readiness, business models, market research, marketing and branding, digital marketing, financial analysis, business planning, performance management, social impact assessment, funding avenues and business leadership.

The curriculum, designed by external expert facilitators and staff from IPPF, Member Associations (MAs), and FPA, was tailored to meet the specific needs of participants. A pre-workshop meeting was held a week before the main event to outline course content, expected outcomes, activities, and to facilitate initial participant connections.

Training methodologies employed during the workshop included trainer-led sessions, interactive discussions, Q&A segments, team-building activities, and experience sharing. Additionally, an informative video series titled "The Buzz" featuring renowned Sri Lankan business leaders and entrepreneurs, who share their knowledge, experiences, challenges, and practical tips on building successful enterprises were showcased during relevant sessions. Sessions were simultaneously professionally interpreted in Spanish and French, and all workshop materials were translated accordingly.

The online format of the training involved systematic planning and creative interventions to maintain participant engagement. Group activities, particularly icebreakers, fostered a sense of community, informal conversations, camaraderie, and networking skills.

On the closing day, participants shared their experiences, followed by a certificate awarding ceremony attended by well-wishers from the Federation, Executive Directors, and Senior Management teams, trainers, and external personnel. This workshop is vital to IPPF's mission of empowering associations for financial sustainability, aiding participants in developing start-up ideas or expanding their Social Enterprise activities into sustainable and impactful ventures. Income generated by Social Enterprises (SEs) enhances financial sustainability, reducing dependence on donors and grant-giving foundations or government agencies.

Where applicable, and in response to ongoing interest from Member Associations, the Hub will continue to provide guidance, technical assistance, and further training. Participants were required to submit an "Action Log," detailing their learning points, actions to be taken to start or expand an SE at their MA, and realistic timelines.










Over two weeks, the programme covered a wide range of essential topics for Social Enterprises (SE). Week 1 included an introduction to SE, panel discussions on the need for social enterprising, organizational readiness assessments, and explorations of SE impact models, business models, and key success factors.

It also featured market research, basic marketing principles, and digital marketing strategies, with experience-sharing from Nepal, Kenya, and Bhutan Associations. Week 2 focused on business plan drafting, SE performance management, impact assessment, and capital raising options through panel discussions. It also included sessions on digitalization for SE, e-commerce operations, organizational culture management, inspirational leadership, and business leadership for SE.







MSe 2024 was the SE Hub's sixth global workshop and fifth edition under this theme. Individual capacity-building programmes like this are essential for IPPF Associations to ideate and incubate a new income-generation venture or grow an existing one, all of which ultimately strengthen the organization's sustainability.

This year's event was most likely our toughest assignment, and yet one that has ended with many positives and new collaborations being formed. It was personally exciting and fulfilling for me to have led, coordinated and moderated this programme.

Strengthening Support: Advocacy Workshop on Gender-Based Violence and Counselling

The Advocacy Unit hosted an impactful three-day residential workshop from June 26-28, 2024, at Mirage Hotel, Colombo. The event featured sessions on critical topics such as gender-based violence, referral standard operating procedures (SOPs) and advanced counselling methods.

Participants received training in counselling tools and techniques including Cognitive Behavioral Therapy (CBT), art therapy, relaxation techniques, Lifeline and SWOT analysis. They also learned essential skills in record keeping, case conferences and referrals.

Expert speakers included Anoja and Iresha from Women in Need, along with Ms. Hema Ranawake (Assistant Director - Alokaya Counselling Centre), Ms. Badra Udawatta (Deputy Director - SRH Institute), and Ms. Rasika (Counsellor) from FPA Sri Lanka. This workshop was specially designed for the managers and counsellors of FPA's Service Delivery Points.





FPA Sri Lanka's SEAP Project Wins Again at the National Project Management Excellence Awards (NPME 2024)!



We are thrilled to announce that FPA Sri Lanka's SEAP Project has won for the second consecutive year at the NPME Awards held on Friday the 31st of May at the Galadari Hotel, Colombo.

In 2015, IPPF launched the Social Enterprise Acceleration Program (SEAP) to empower The International Planned Parenthood Federation Member Associations (MAs) with entrepreneurial best practices in the health sector, delivering social impact and improving lives. SEAP aims to establish and grow social enterprises, diversifying funding sources and ensuring sustainability.

Since 2018, FPA Sri Lanka has been functioning as the Social Enterprise Hub (SE Hub), ensuring the successful implementation of SEAP. The programme fosters a

'community of practice,' enabling Member Associations (MAs) to share best practices and lessons learned. The SEAP programme includes MA-to-MA knowledge sharing, mutual support, capacity building, assistance in establishing revenue-generating business models, and providing technical assistance to transform income-generating activities into social enterprises. It also promotes impact-driven social enterprises.

At the NPME Excellence Awards 2024, under the 'Best Managed Project in Social Enterprise Sector (Local and International) category, the SEAP Project emerged as the 'Silver Award' winner. The award recognized our initiatives in supporting 12 IPPF MAs in Social Enterprise related market research for 2022/2023/2024. The SE Hub also developed a custom Market Research Framework (MRF) featuring globally recommended best practices and industry-standard analytical tools for IPPF Social Enterprises.

These prestigious awards are organized by the Project Management Institute (PMI) Sri Lanka Chapter, the official Chapter of the global Project Management Institute, USA. PMI is the world's leading professional association for project, programme, and portfolio management. This recognition motivates us to further strengthen social enterprises across the Federation, manage our programme more robustly, and deliver even more effective results.

In conversation with Mr. Amal Sugath Bandara Assistant Director - M&E

Could you share with us your professional journey, highlighting key milestones and experiences that have shaped your career?

In 2007, I began my Monitoring & Evaluation (M&E) career as а district-level Officer M&E for a livelihood development project implemented by an international NGO. This role marked a significant milestone in my professional journey. One of the first major opportunities I encountered was an international training program on Enhancing the Country's M&E Function, which sparked my interest in M&E processes and methods which are essential for improving the efficiency. effectiveness, relevance, impact, and sustainability of project results for beneficiaries. By the end of the project, I had gained substantial experience in applying various M&E processes across different stages of the project cycle.

In 2013, I joined FPA Sri Lanka as an M&E Officer for a Global Fundsupported HIV programme, marking another significant milestone. This position presented new challenges, as I was responsible for overseeing and implementing the M&E function across more than 10 districts through 20 local Leveraging my previous experience and the support of M&E management, I broadened my technical knowledge and effectively implemented the M&E function. This role also provided opportunities to engage with national and international M&E experts, participate in professional M&E forums on HIV/AIDS and SRHR, and contribute developing M&E procedures, MEIMS, strategic planning, evaluations, and research publications.


After five years, I was appointed Assistant Director - M&E, marking the milestone in my career. third Encouraged by the Head of M&E, I completed a Postgraduate Diploma in Monitoring and Evaluation from the University of Sri Jayewardenepura. This diploma complemented the short courses I had completed during my tenure at FPA Sri Lanka and significantly enhanced my expertise. The supportive learning environment at FPA Sri Lanka has not only shaped my M&E career but also contributed to the development of other team members in the unit.

Additionally, what drives your passion within your field of work?

I am passionate about serving underprivileged, underserved, and marginalized communities, including those in rural and plantation sectors. M&E provides valuable opportunities to hear the voices of these communities.

Through monitoring activities, I can contribute to assessing whether we are meeting community expectations as planned, identifying deviations, and understanding the reasons behind them. This process fosters meaningful engagement with the communities. Additionally, participating in the evaluation process allows us to determine whether we are taking the right actions to fulfill the needs and address the gaps within these communities.

What do you believe are the most



In the NGO context, I believe an effective M&E system includes an organizational structure, a robust monitoring data management system, operational research and evaluation studies, an annual costed M&E work plan, supportive supervision, data auditing, and data dissemination and use. The organizational structure should have effective M&E leadership, skilled staff, a strong M&E culture, and a clear framework. Robust and routine monitoring provides essential data for decision-making. Operational research evaluation offer and strategic information as evidence of intervention success and contribute to knowledge management. A costed annual M&E work plan ensures adequate allocation for capacity development, supervision, and studies. Supportive supervision enhances

staff skills, while data audits improve data quality. Disseminating data internally and externally ensures its effective use in planning, implementation, and policy formulation.

Can you share a specific example of a successful M&E initiative of FPA, highlighting the impact it had on programme effectiveness and decision-making?

The Monitoring and Evaluation Information Management System (MEIMS) was successfully integrated with real-time data collection in 2021, marking a significant M&E initiative. Real-time data is gathered through the "D2D Care" and "Client Feedback" applications. Volunteer health workers use the D2D Care app to record service delivery data during client interactions. while the Client Feedback app captures services perceptions of clients' provided by both static and mobile This system enables clinics. management to monitor community -based service provision regularly and offer necessary guidance.



Reviewing client feedback allows management to improve client satisfaction. With pre-defined reports in MEIMS, this initiative facilitates quick decision-making to enhance programme effectiveness from service delivery to the national level of FPA Sri Lanka.

How do you ensure that M&E processes are integrated seamlessly into project planning and implementation phases in FPA?

M&E processes begin at the project planning stage. This stage includes conducting a situational analysis, defining SMART objectives and results, establishing performance indicators, and developing data collection tools.

I support this process by ensuring clear indicator definitions, aligning with FPA Sri Lanka and donor requirements on indicator disaggregation, and advocating for the allocation of necessary funds for M&E activities throughout the project period.

During the implementation stage, I work closely with the project team, beneficiaries, and stakeholders to assess the efficiency and effectiveness of delivering expected results. This involves conducting regular supervisory visits and data quality audits, analyzing routine monitoring data, and sharing findings on strengths and gaps to enhance project results and processes.

What strategies do you employ to ensure that M&E findings are effectively communicated to relevant stakeholders, both internally and externally?

Effective internal and external communication of M&E findings is crucial in the development sector. I prepare periodic updates and review reports to share with management, teams, government project and non-governmental stakeholders. including donors. Another strategy involves creating tailored reports based on specific stakeholder requirements. By clearly defining these requirements in collaboration with all relevant stakeholders, I can produce customized reports that meet their needs.

Additionally, I present findings at formal meetings with internal staff and external stakeholders to share insights and advocate for recommendations. This approach allows participants to provide feedback, reach a consensus on the findings, and agree on actionable recommendations.

Furthermore, we conduct research using internal programme data to publish research articles, which are shared with a wider audience at national and international levels, thereby contributing to the body of knowledge. If specific expertise is needed, I collaborate with universities or institutions, provided there is budgetary allocation for such studies.

As an M&E Assistant Director, how do you ensure that the data collected and analysed are used to drive meaningful improvements in programme design, implementation, and impact?

Engaging internal and external stakeholders is essential for effectively communicating M&E findings. Internally, I engage with the project management team to provide updates on progress against targets, share findings during regular project reviews, and organize ad-hoc meetings to debrief on findings that require urgent action.

To formalize these processes, I distribute reports that include findings and feasible recommendations at various levels. I also conduct follow-up visits to update progress on the implementation of previous recommendations and continuously report on relevant recommendations.

I submit periodic reports that include analyses providing insights into the project's strengths and gaps. I facilitate regular presentations of findings to external stakeholders. In instances where special analyses of current projects are required, we provide detailed analyses based on existing programme data and present these findings to help design new project proposals and concept notes. Additionally, I contribute to publish research papers based on these analyses.

Through qualitative analysis, I support compiling success stories from different thematic areas, covering various donor-funded projects, to highlight our achievements and impact.

Please share any words of encouragement or advice for your colleagues at the FPA and individuals considering entering the field of M&E.

M&E is a multidisciplinary field that requires individuals, including newcomers and colleagues, to be open-minded and lifelong learners due to its rapidly evolving nature.

To excel in M&E, one must continuously improve in various areas, such as research methods application, quantitative and qualitative data analysis, data management, and people management skills.

Most data collection methods in M&E are rooted in research methodologies approaches. Therefore, M&E professionals need to enhance their knowledge of analysis techniques and the use of various software to facilitate both quantitative and qualitative data analysis. Monitoring, in particular, involves regular data collection, necessitating a thorough understanding of data types, variables, and principles of data management. Proficiency in IT packages that support data management is also advantageous for M&E professionals.

Additionally, individuals aspiring to lead M&E teams or serve as heads of M&E should be prepared to manage people, as they are responsible for supervising M&E teams.



"Bridging the GAP" Sexuality Education Programme at LEO Club



Effective communication and emotional intimacy are crucial for healthy relationships. Open, honest, and empathetic communication fosters emotional closeness, forming a strong foundation for fulfilling relationships.

FPA Sri Lanka and the LEO Club of SLIIT-Malabe organized the "Bridging The GAP" workshop for students, featuring Ms. Hema Ranawake Assistant Director at FPA's Alokaya Counselling Centre and Mental Health Professional Ms. Kusumanjalee Thilakarathne.

In Sri Lankan culture, discussing sex education openly is often uncomfortable. Our aim is to foster greater understanding among young adults, so they have fewer problems with their sexual health and relationships.

The session addressed:

• Enhancing communication: Encouraging open dialogue between partners about sexual desires.

- Promoting mutual understanding: Helping young adults understand each other's sexual needs and preferences.
- Addressing challenges: Tackling issues like mismatched libidos, performance anxiety, and changing sexual desires over time.
- Building confidence: Empowering individuals to confidently communicate their needs and desires.
- Love in the digital age: Finding love online, recognizing red flags, sexting, texting, consent, and setting relationship goals.
- Providing accurate information: Offering comprehensive information about sexual health, anatomy, contraception, and STIs.

FPA's Happy Life Centre also provided information on contraceptives and sexual and reproductive health.

Alokaya - Helping teens manage their stress



FPA's Alokaya Counselling Centre conducted a Stress Management Programme for students aged 17 – 19 years at Rajakeeya Vidyalaya-Horana. The session addressed:

- · What is stress, and how it affects us
- Identifying our stressors
- Stress Management techniques

Adolescence is a crucial transition period from childhood to adulthood, marked by numerous challenges that can impact health. As teenagers' brains mature, they undergo significant changes, creating stressful situations. Relationships with peers and social experiences become increasingly important, and gaining independence becomes a priority. This period of heightened "storm and stress" makes stress management essential for maintaining good physical and mental health.





The Outreach Unit has successfully conducted multiple donations of Dignity Kits, ensuring they are disability inclusive, this quarter. These kits provide essential hygiene and sanitation items like clothing, sanitary pads, and soap, enabling recipients to uphold their hygiene and dignity. With the support of UNFPA and the People of Japan, FPA Sri Lanka is committed to advocating for and working towards ensuring individuals with disabilities have access to sexual and reproductive health information, education, and services. Moreover, our goal is to foster environments that are free from violence and discrimination, empowering individuals with disabilities to fully exercise their rights. Distribution events were held in the divisional secretariats of Thimbirigasyaya, Seethawaka, Ambalangoda, Balapitiya, and Batticaloa, accompanied by the distribution of informative leaflets to the recipients.

Improving Youth Sexual and Reproductive Health



The 35th Youth Camp was successfully conducted at Anamaduwa Technical College in the Puttalam District. It provided a platform of learning through dialogue, workshops and capacity building sessions regarding various topics relating to SRH.

Associated Clinic at Lootah Garments (Pvt) Ltd

The factory's health unit has received contraceptive products and informative leaflets detailing crucial sexual and reproductive health (SRH) information. Going forward, the SDP will conduct routine health clinics directly at the factory site, offering employees easy access to essential services. Additionally, employees are encouraged to utilize the SDP for SRH support and counselling whenever needed. This initiative aims to prioritize the health and well-being of all factory personnel.

Led by the skilled production staff from Selyn, who shared their journey of high-quality sanitary developina napkins, participants learned about quality standards, testing, and the importance of sustainable menstrual products.



The momentum continued into the session at Dewasarana Development Centre, where partner NGOs came together to learn and share experiences. Ms. Paba Deshapriya from the Grassrooted Trust served as the resource person, shedding light on impactful work in this area, inspiring participants to drive positive change in their communities

By fostering collaboration and knowledge-sharing, we strengthened our collective efforts to combat period poverty and break down barriers to menstrual health, paving the way for a more inclusive and equitable future.

The CAAPP Project, implemented by the Embassy of France to Sri Lanka and Maldives in partnership with FPA Sri Lanka, aims to uplift menstruating individuals by improving menstrual health and hygiene, ending stigma and discrimination, ensuring water and sanitation rights, addressing the lack of adequate WASH facilities in schools, and reshaping societal views on menstruation and womanhood.

Community-led monitoring (CLM) is an important aspect of community engagement in HIV programme delivery. It involves community-based organizations and members assessing the quality and accessibility of the HIV services they receive to advocate for improvements in service delivery.

The Power of Dialogue: Community-Led Monitoring in Action



Discussions play a pivotal role in shaping our work, particularly highlighted in a briefing led by Mr. Manju Hemal, Project Coordinator, and Mr. Saman Kumara, Chairperson of Heart to Heart. They provided a comprehensive overview of Community-Led Monitoring (CLM) to dedicated outreach workers who link clients to critical HIV services. This approach not only strengthens workers' ability to facilitate HIV service access but also enhances the feedback mechanism, fostering continuous service delivery improvement.

Enhancing HIV Services through Community-Led Monitoring



Receiving feedback from community members and workers is crucial for the success of the Community-Led Monitoring (CLM) programme. In a recent meeting in Anuradhapura, the second phase targeting the North Western, Northern, and North Central provinces was discussed.

Engaging Key Populations in Legal Literacy and Advocacy



Under Objective 4 of the SKPA-2 programme, FPA has engaged Dr. Kaushalya Ariyarathne to lead Legal Literacy and Advocacy Capacity - Building Workshops next quarter. Earlier, Ms. Hasanah Cegu conducted Focus Group Discussions (FGDs) with representatives from Tamil- speaking key populations to assess their specific needs. Based on these insights, consultants will draft a comprehensive training plan tailored to each key population, including advocacy and legal training modules to enhance their capacity to advocate for their rights effectively.

The main objective of these FGDs is to determine advocacy priorities, identify knowledge gaps, and assess the skills and capacity needed to advocate for change effectively within each key population component.

Sensitization Programme on SRH in Emergencies for Youth with Disabilities



A two-day Sensitization Programme on Sexual and Reproductive Health (SRH) in Emergencies for Youth with Disabilities is being held today and tomorrow at the Granbell Hotel. Organized under the SPRINT project, the programme includes 20 participants from the University of Colombo, the University of Kelaniya, and the University of Sri Jayewardenepura.

The sessions are facilitated by Dr. Lahiru Kodithuwakku and Dr. Chintha Rupasinghe, experts in community medicine and disaster management. Topics include Sri Lanka's disaster profile, maintaining personal hygiene and protection during disasters, and addressing SRH issues in such situations. The interactive activities ensured participants could fully grasp and apply the important information shared.


